6. Unless otherwise indicated, all tests were conducted on Models DH-IPC-HFW4431SP to represent the other similar models.

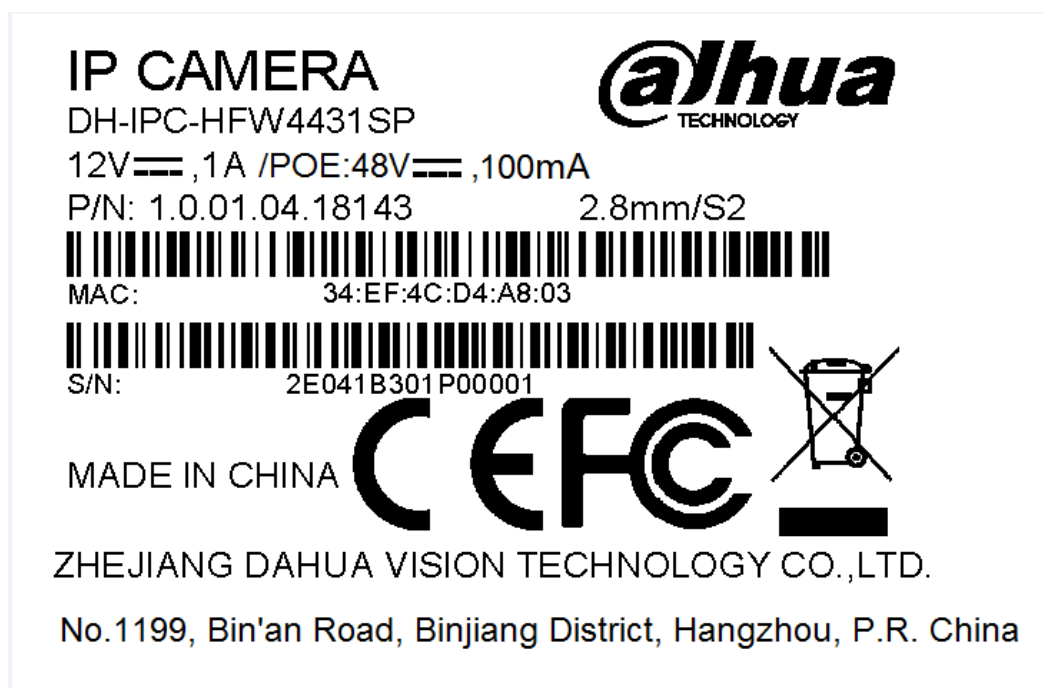
