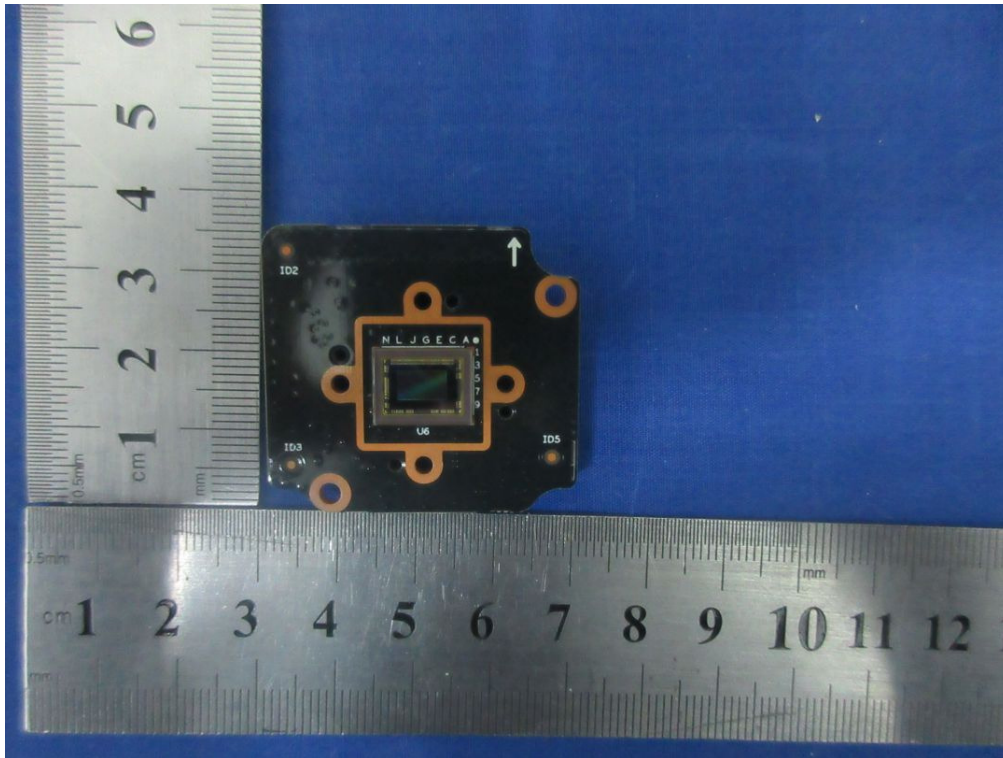
Sensor board for model DH-IPC-HDBW5231RP-Z



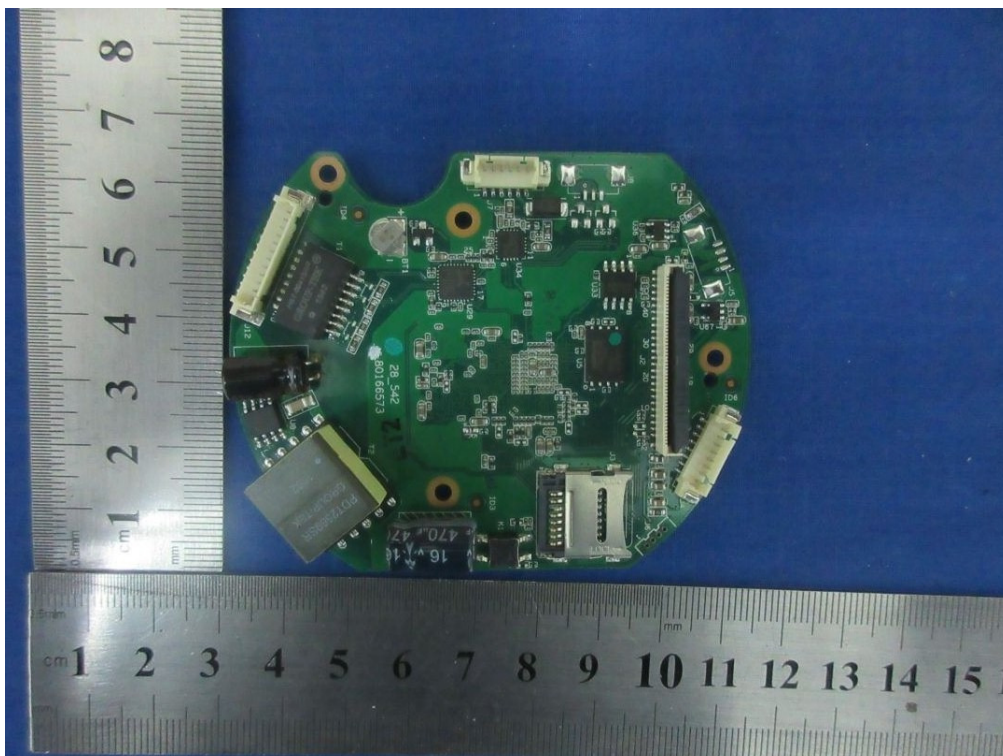

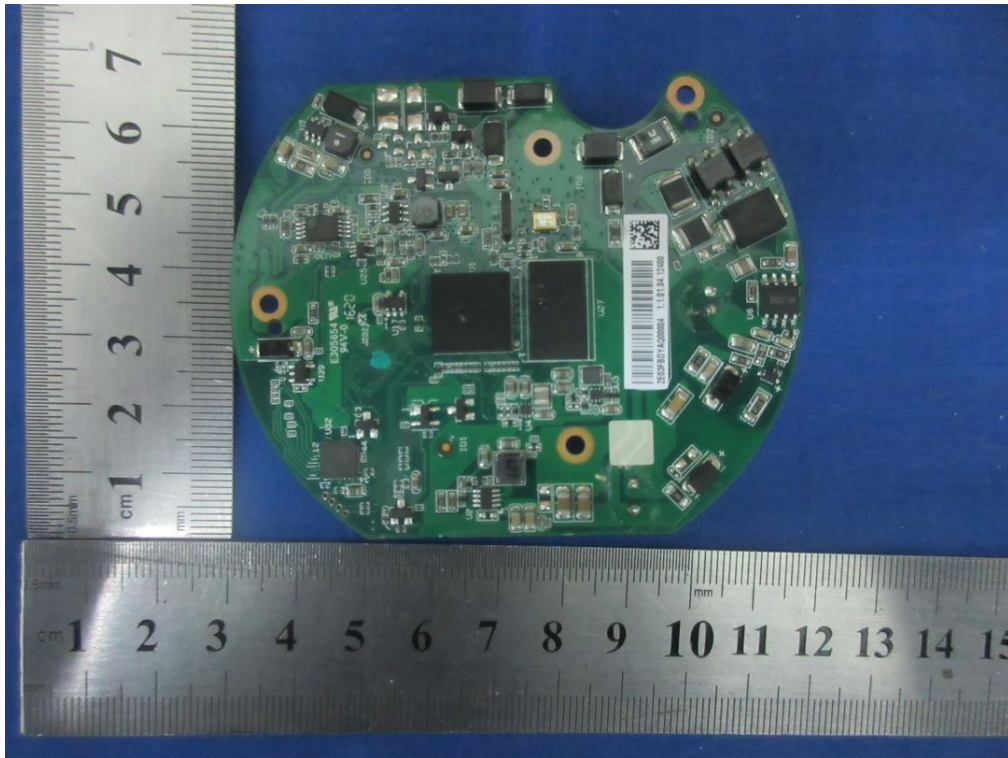


Main board for model IPC-HDBW5830RP-Z-S2

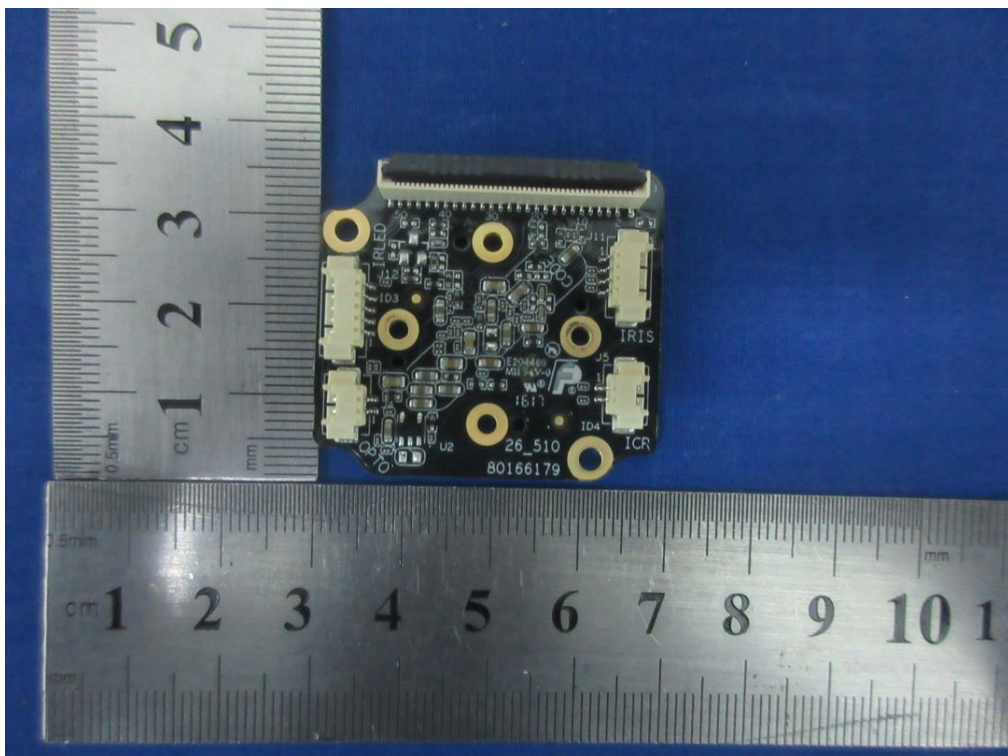

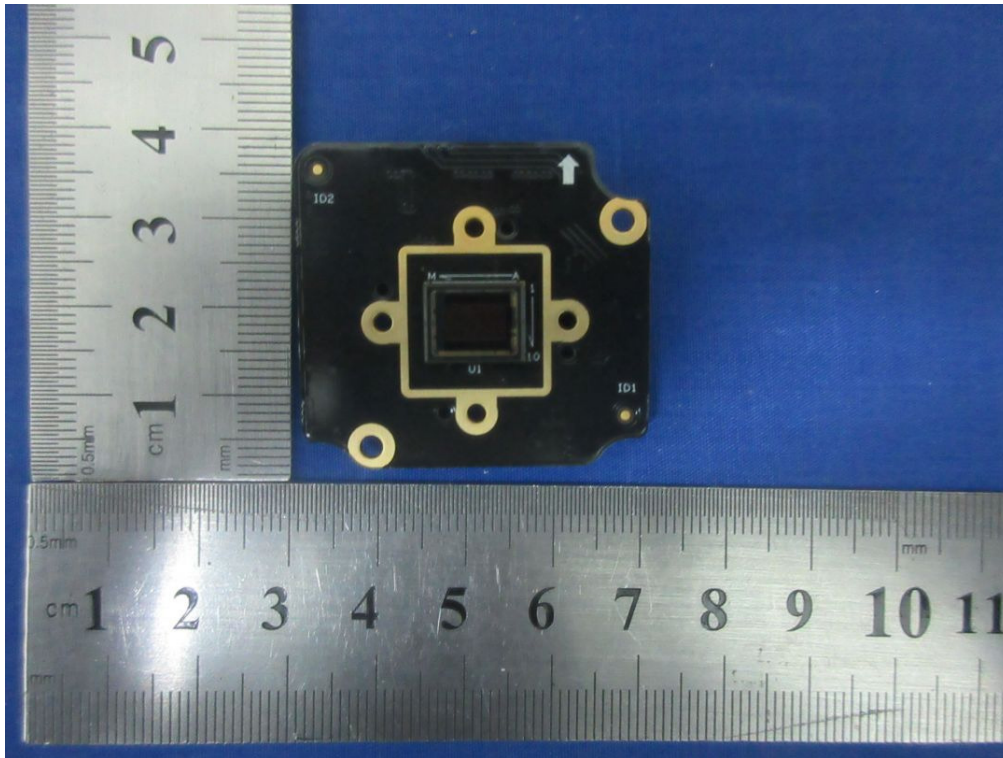
Sensor board for model DH-IPC-HDBW5830RP-Z



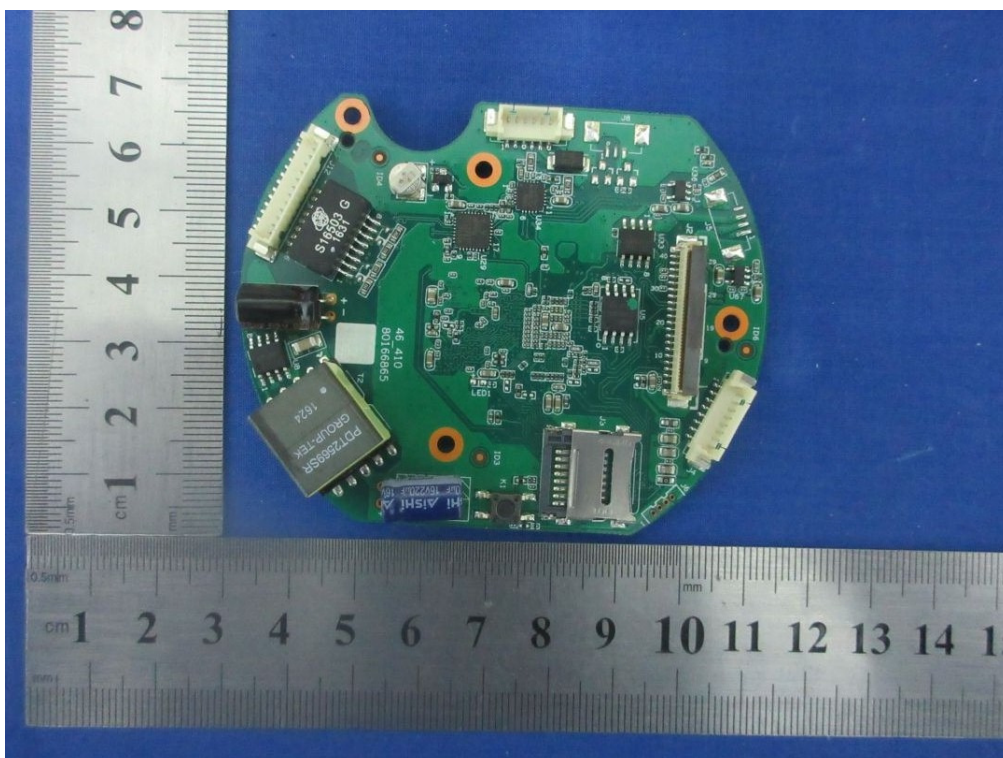

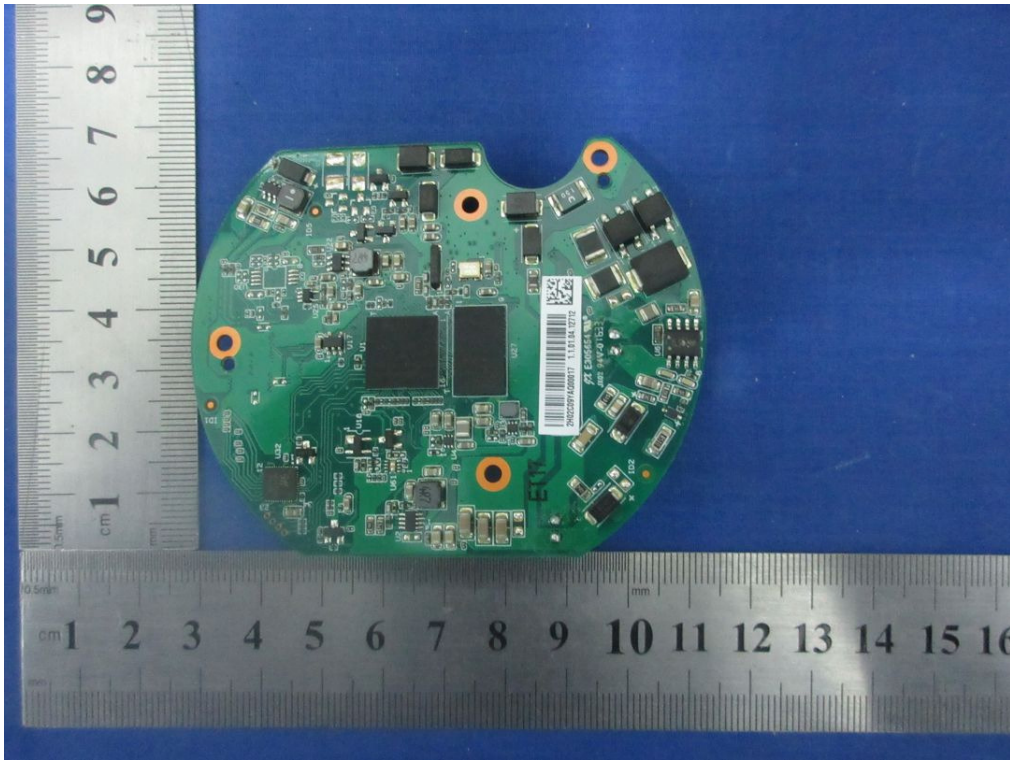


Main board for model DH-IPC-HDBW2230RP-ZAS

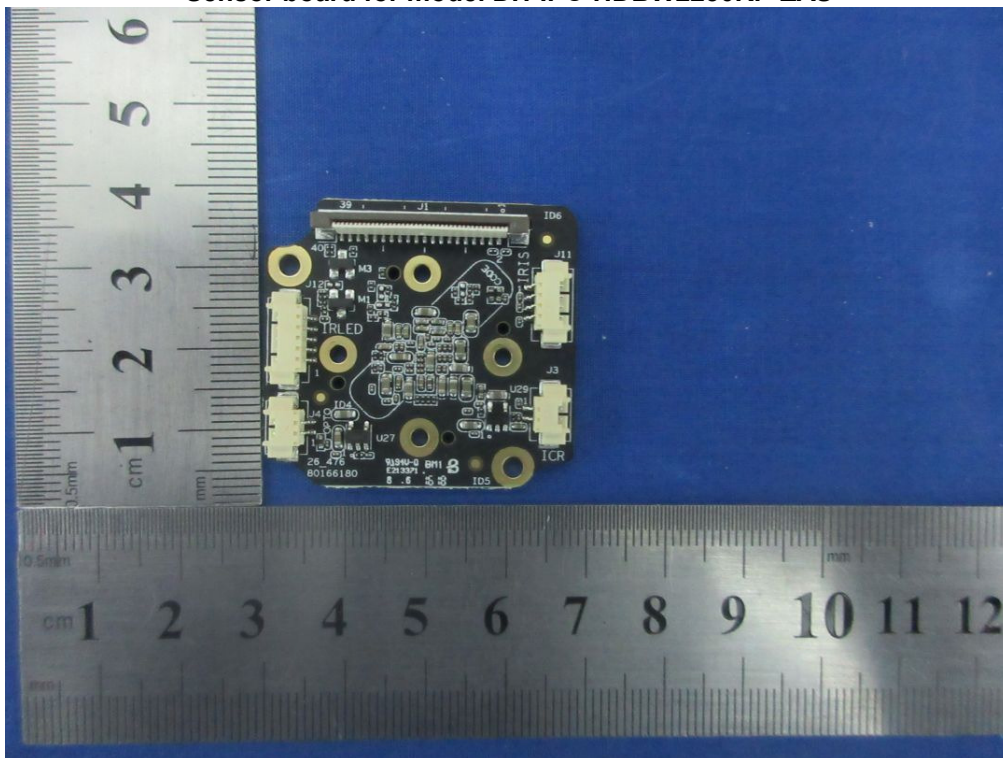
