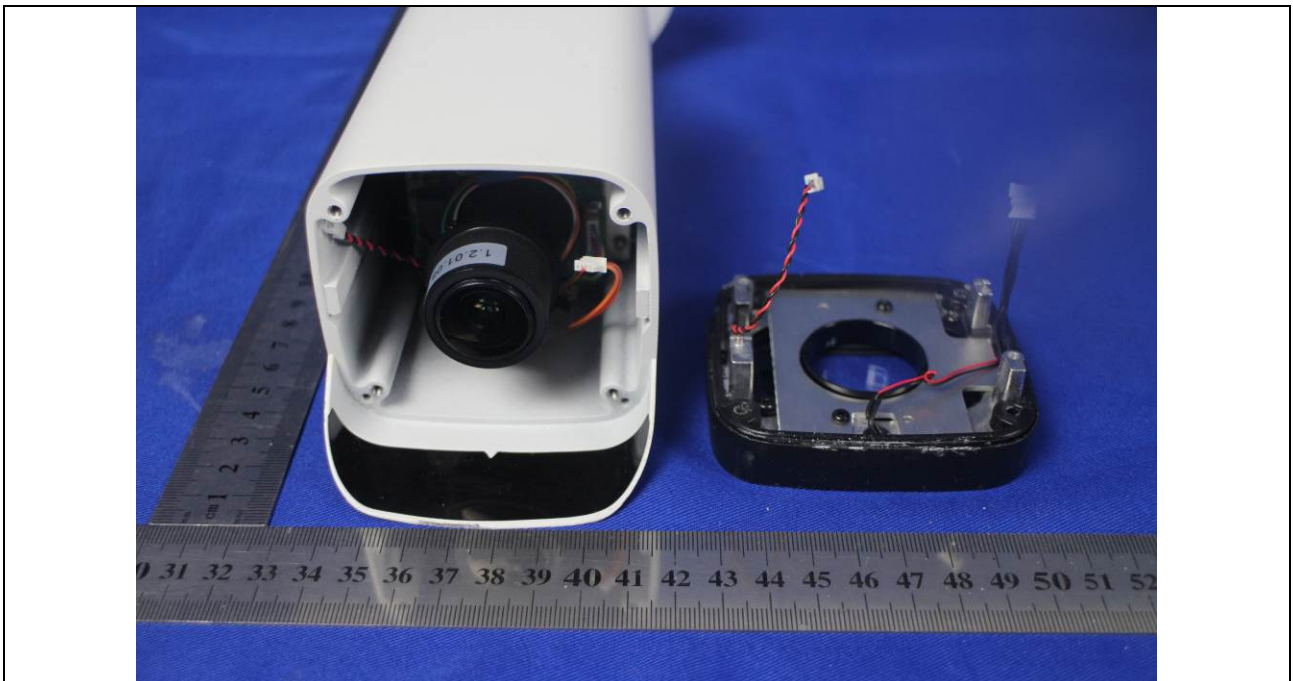

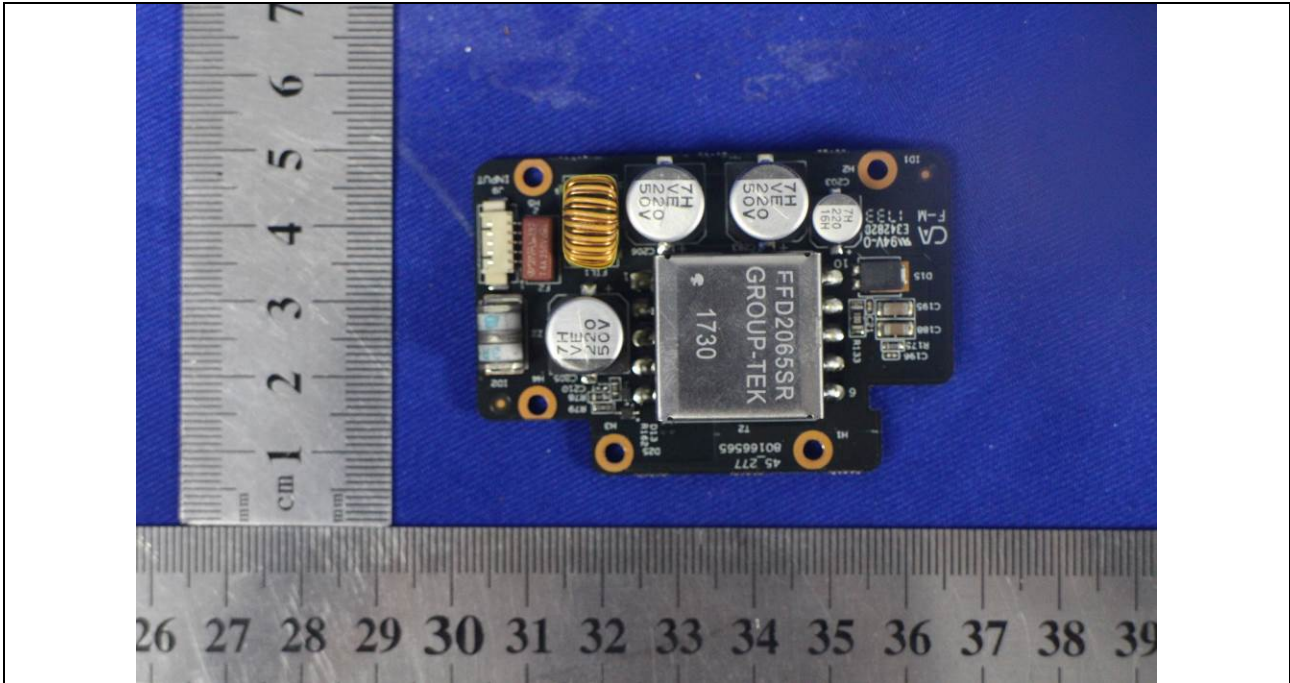

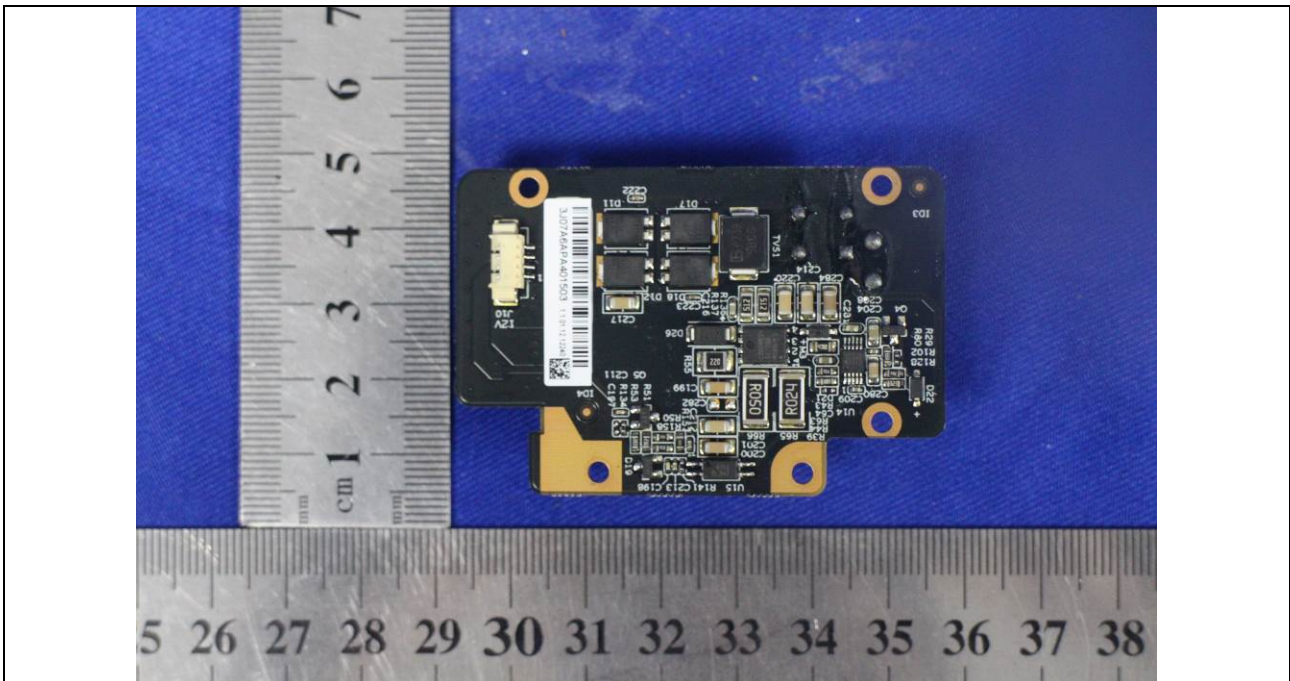

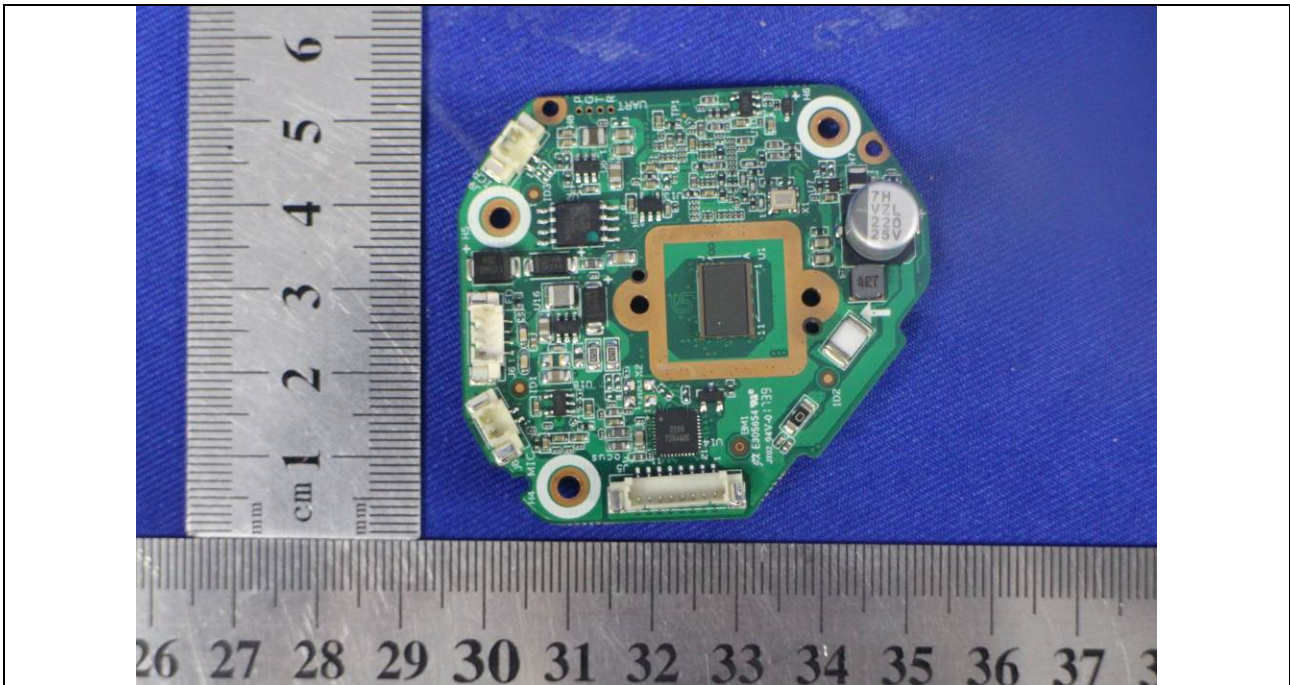
Details of: PCB-1 (24VAC power board)



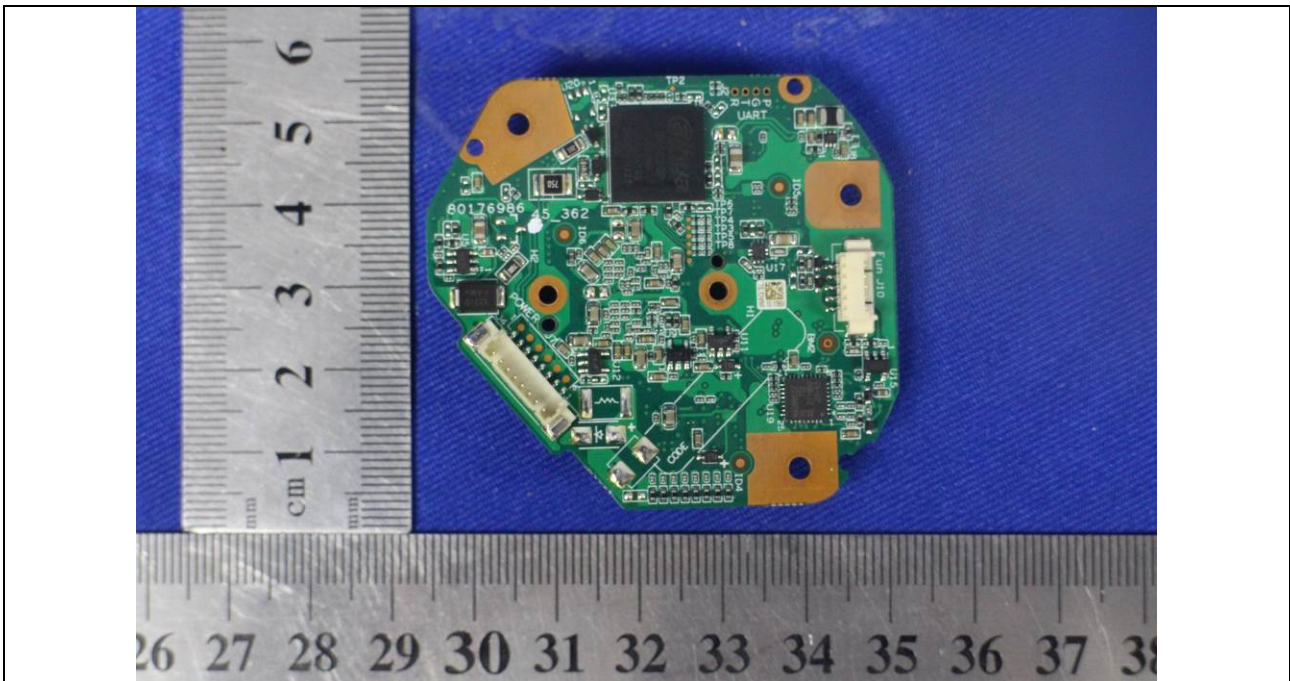

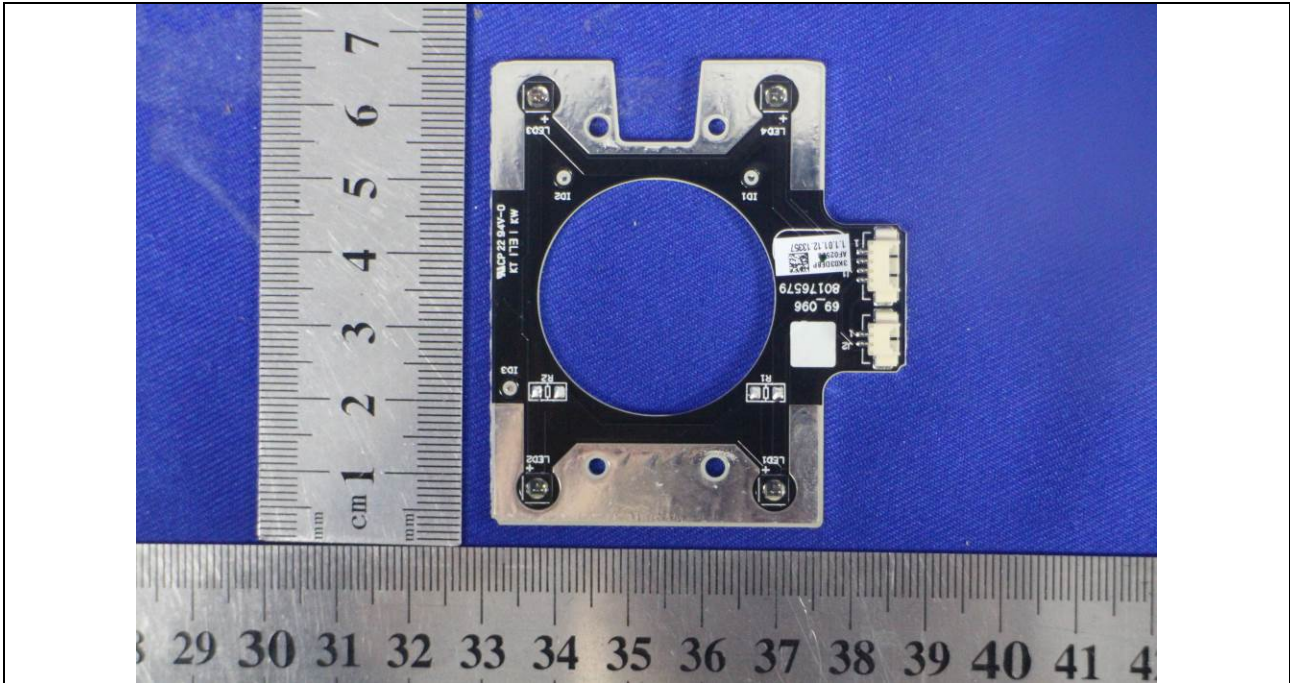
